## AB 2011:

#### AFFORDABLE HOUSING & HIGH ROAD JOBS ACT 2022

Creates a ministerial, streamlined approval process for projects meeting affordability, location, objective standards and labor requirements.

## SB 6:

#### MIDDLE CLASS HOUSING ACT OF 2022

- Allows housing development projects in zones where office, retail or parking are permitted, if they are not adjacent to industrial-use parcels.
- Objective Standards
- Labor Requirements
- Permits projects to apply for a density bonus.
- Allows local agencies to adopt implementing ordinances, which are not subject to the California Environmental Quality Act.
- Eligible parcels may qualify for streamlined ministerial approval under SB 35 is certian requirements are met.
